CLAUSE 1: CO-OPERATION

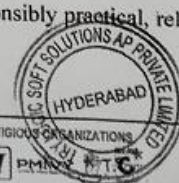
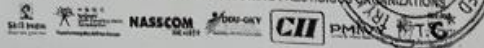

Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

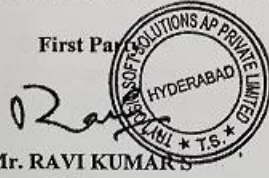
CLAUSE 3: VALIDITY
